- 2.6 SWOT Analysis. All FC members asked to present a list of Strengths and Weaknesses of the ACDS from their State's point of view. It was considered that this would take time to discuss and that a dedicated meeting should be convened to discuss this in early 2023.

3.0 New Business

3.1 Review of the Constitution

Legal advice from Western Australia is that the Constitution has flaws and need review. No specific areas have been given, but costing have been presented, suggesting a new constitution (including provisions relating to discipline and dispute resolution) could be produced for the ACDS for consideration for \$2,000 to \$3,000. Another quote estimated a cost of between \$5,000 and \$10,000 for a first draft.

This is being considered.

3.2 Honorary Life Membership

Discussion regarding a Policy for ACDS Honorary Life Membership. A Draft proposal was presented and discussed. Some changes needed and these will be included in the document by the VP. Once this is complete, the Application Form will be altered to reflect the changes and both sets of documents will be sent to the FC members via email for approval.
